# Existence and Uniqueness of Solutions for the Initial Value Problem of Fractional $q_{k}$-Difference Equations for Impulsive with Varying Orders*

#### Abstract

The paper studies the existence and uniqueness for impulsive fractional $q_{k}$-difference equations of initial value problems involving RiemannLiouville fractional $q_{k}$-integral and $q_{k}$-derivative by defining a new $q$-shifting operator. In this paper, we obtain existence and uniqueness results for impulsive fractional $q_{k}$-difference equations of initial value problems by using the Schaefer's fixed point theorem and Banach contraction mapping principle. In addition, the main result is illustrated with the aid of several examples.


Keywords Impulsive fractional $q_{k}$-difference equation, Boundary value problem, Existence, Uniqueness.

## 1. Introduction

Fractional calculus is a relatively new research field, and it can describe certain phenomena as well, which has attracted increasing attention in recent years. The quantum calculus is known as the calculus without limits. It substitutes the classical derivative by a difference operator, which allows one to deal with sets of nondifferentiable functions. Quantum difference operators appear in several branches of mathematics, i.e., basic hype-geometric functions, combinatorics, the theory of relativity. For the fundamental concepts of quantum calculus, we refer to the reader to the work by Kac and Cheung $[5,8]$.

In the recent years, the topic of $q$-calculus has attracted the attention of several researchers, and a variety of new results can be found in the papers $[3,4,7,9,10$, $12-14,22$ ] and the references therein. In real life, there are many processes and phenomena that are characterized by rapid changes in their state. We usually keep things instantaneous mutations occurred in the process of its development called impulsive phenomena. The phenomenon has been widely appearing in all fields of production and technology research. The most prominent feature of impulsive differential equations is taking the influence of the condition of sudden and abrupt phenomenon into full consideration. It has been extensively used in population

[^0]ecological dynamics systems, infectious disease dynamics as well as descriptions of phenomenon like disease, harvesting and so on.

Impulsive differential equations, in other words, differential equations involving impulsive factors, appear as a natural description of observed evolution phenomenon of several real world problems. For some monographs on impulsive differential equations, we refer to $[6,20,21]$.

In [16], the notions of $q_{k}$-integral of a function $f: J_{k}:=\left[t_{k}, t_{k+1}\right] \rightarrow \mathbb{R}$ have been introduced, and their basic properties were proved and applied, Tariboon et al., investigated the first and second-order initial value problems of impulsive $q_{k^{-}}$ difference equation respectively, as shown below

where $x_{0} \in \mathbb{R}, \alpha, \beta \in \mathbb{R}, 0=t_{0}<t_{1}<t_{2}<\cdots<t_{k}<\cdots<t_{m}<t_{m+1}=T, f:$ $J \times \mathbb{R} \rightarrow \mathbb{R}$ is a continuous function, $I_{k} \in C(\mathbb{R}, \mathbb{R}), \Delta x\left(t_{k}\right)=x\left(t_{k}^{+}\right)-x\left(t_{k}\right), k=$ $1,2, \cdots m$ and $0<q_{k}<1$ for $k=0,1,2, \cdots m$. In addition, $q_{k}$-calculus analogues of some classical integral inequalities, such as Hölder, Hermite-Hadamard, Trapezoid, Ostrowski, Cauchy-Bunyakovsky-Schwarz, Grüss and Grüss-Cebysev, were proved in [17].

In 2015, Agarwal et al., [2] investigated the existence of positive solutions for nonlinear impulsive $q_{k}$-difference equations via a monotone iterative method

where $f \in C\left(J \times \mathbb{R}, \mathbb{R}^{+}\right), I_{k} \in C\left(\mathbb{R}, \mathbb{R}^{+}\right), J=[0, T], T>0,0=t_{0}<t_{1}<t_{2}<$ $\cdots<t_{k}<\cdots<t_{m}<t_{m+1}=T, J^{\prime}=J \backslash\left\{t_{1}, t_{2}, \cdots t_{m}\right\}, J_{r}=\left(t_{r}, T\right), 0 \leq \lambda<$ $1,0 \leq r \leq m$ and $\Delta u\left(t_{k}\right)=u\left(t_{k}^{+}\right)-u\left(t_{k}^{-}\right), u\left(t_{k}^{+}\right)$and $u\left(t_{k}^{-}\right)$denote the right and left limits of $u(t)$ at $t=t_{k}(k=1,2, \cdots m)$ respectively.

In [18], the new concepts of fractional quantum calculus were defined by introducing a new $q$-shifting operator. After giving the basic properties of the new $q$-shifting operator, the $q$-derivative and the $q$-integral were defined. New definitions of the Riemann-Liouville fractional $q$-integral and $q$-difference of an interval $[a, b]$ were given, and their properties were discussed. As applications, the authors obtained the existence and uniqueness results of initial value problems for impulsive fractional $q_{k}$-difference equations of the orders $0<\alpha<1$ and $1<\alpha<2$ respectively, as shown below,

Inspired by the above papers, in this paper, we study the following initial value problem of the impulsive fractional $q_{k}$-difference equation

where $\beta \in \mathbb{R}, 0=t_{0}<t_{1}<t_{2}<\cdots t_{m}<t_{m+1}=T, f: J \times \mathbb{R} \rightarrow \mathbb{R}$ is a continuous function, $\varphi_{k}, \varphi_{k}^{*}, \varphi_{k}^{* *} \in C(\mathbb{R}, \mathbb{R})$ and $x(t)$ are continuous everywhere except for some $t_{k}$ at which $x\left(t_{k}^{+}\right)$and $x\left(t_{k}^{-}\right)$exist and $x\left(t_{k}^{-}\right)=x\left(t_{k}\right)$ for $k=1,2, \cdots m, 0<$ $q_{k}<1$ for $k=0,1,2, \cdots m$, and $t_{k} D_{q_{k}}^{\alpha_{k}}$ denotes the Riemann-Liouville $q_{k}$-fractional derivative of the order $\alpha_{k}, J_{k}=\left(t_{k}, t_{k+1}\right]$, especially $J_{0}=\left[0, t_{1}\right]$. Moreover,

The main innovation points of this paper are as follows:

1. Compared with [18], our paper has been improved for the order of the equation.
2. The order of the equation studied in most papers is fixed, while the order of the equation we study varies with $k$, a change in $k$ causes a change in order, which adds to the difficulty of the paper.

This paper is organized as follows. In Section 2, we present some preliminaries. Section 3 contains the main results, which are established by means of Schaefer's fixed point theorem and Banach contraction mapping principle, while several examples are illustrated the main results in Section 4.

## 2. Preliminaries

To get the main results, we present some knowledge of fractional $q_{k}$-calculus. The presentation here can be found in [18].

For any positive integer $k$, the $q_{k}$-shifting operator

Definition 2.1. [18] Assume that $f: J_{k} \rightarrow \mathbb{R}$ is a continuous function, and let $t \in J_{k}$. Then, the expression

is called the $q_{k}$-derivative of a function $f$ at $t$.
We say that $f$ is $q_{k}$-differentiable on $J_{k}$, provided $D_{q_{k}} f(t)$ exists for all $t \in J_{k}$. Note that if $t_{k}=0$ and $q_{k}=q$ in (2.1), then $D_{q_{k}} f=D_{q} f$, where $D_{q}$ is the $q$-derivative of the function $f(t)$.

The $q_{k}$-integral of a function $f$ defined on the interval $[a, b]$ is given by

(i) $W$ is uniformly bounded subset of $P C(J, X)$;
(ii) $W$ is equicontinuous in $\left(t_{k}, t_{k+1}\right), k=0,1,2, \cdots m$, where $t_{0}=0, t_{m+1}=T$;
(iii) $W(t)=\left\{u(t) \mid u \in W, t \in J\left\{t_{1}, t_{2}, \cdots t_{m}\right\}\right\}, W\left(t_{k}^{+}\right)=\left\{u\left(t_{k}^{+}\right) \mid u \in W\right\}$ and $W\left(t_{k}^{-}\right)=\left\{u\left(t_{k}^{-}\right) \mid u \in W\right\}$ is a relatively compact subsets of $X$.

Then, $W$ is a relatively compact subset of $P C(J, X)$.
Theorem 2.3 ( [15]). (Schaefer's fixed point theorem) Let A be a continuous and compact mapping of a Banach space $X$ into itself, such that the set $E=\{x \in X$ : $x=\lambda A x$, for some $0 \leq \lambda \leq 1\}$ is bounded. Then, A has a fixed point.

## 3. Main results

In this section, we will prove the existence and uniqueness of solutions for the following initial value problem for impulsive fractional $q_{k}$-difference equation of order $2<\alpha_{k} \leq 3$, and we use the Banach contraction mapping principle to accomplish the result. In order to achieve the goal, we are supposed to introduce the space: for $\gamma \in \mathbb{R}_{+}, C_{\gamma, k}\left(J_{k}, \mathbb{R}\right)=\left\{x: J_{k} \rightarrow \mathbb{R}:\left(t-t_{k}\right)^{\gamma} x(t) \in\right.$ $\left.C\left(J_{k}, \mathbb{R}\right)\right\}$ with the norm $\|x\|_{C_{\gamma, k}}=\sup _{t \in J_{k}}\left|\left(t-t_{k}\right)^{\gamma} x(t)\right|$ and $P C_{\gamma}=\{x: J \rightarrow \mathbb{R}$ : for each $t \in J_{k}$ and $\left.\left(t-t_{k}\right)^{\gamma} x(t) \in C\left(J_{k}, \mathbb{R}\right), k=0,1,2 \cdots m\right\}$ with the norm: $\|x\|_{P C_{\gamma}}=\max _{0 \leq k \leq m}\left\{\sup _{t \in J_{k}}\left|\left(t-t_{k}\right)^{\gamma} x(t)\right|\right\}$ and $x\left(t_{k}^{+}\right), x\left(t_{k}^{-}\right)$exist, and $x\left(t_{k}^{-}\right)=x\left(t_{k}\right)$, where $k=0,1,2 \cdots m$. Theorem 3.2. Assume that $\left(H_{5}\right)$ and $\left(H_{6}\right)$ hold. Suppose that $B_{1}<1$ holds further, then the boundary value problem (1.2) has at least one solution.

Proof. In view of Lemma 3.1, it is easy to know that $A$ is completely continuous. It is clear that $x(t) \in P C(J, \mathbb{R})$ is a solution of boundary value problem (1.2), if and only if $x$ is a fixed point of $A$. We need to show that the set

Proof. In view of Lemma 3.1, it is easy to know that $A$ is completely continuous. It is clear that $x(t) \in P C(J, \mathbb{R})$ is a solution of boundary value problem (1.2), if and only if $x(t)$ is a fixed point of $A$. We need to show that the set

## 4. Examples

& +\sum_{j=1}^{m}\left(t_{j}-t_{j-1}\right)^{3} L+\sum_{j=1}^{m} L\left(t_{j}-t_{j-1}\right)\left(1-t_{j-1}\right)-\sum_{j=1}^{m} \frac{\left(t_{j}-t_{j-1}\right)^{2}}{1+q_{j-1}} L+\sum_{j=1}^{m}(j-1) \\
& \left.M+\sum_{j=1}^{m} \frac{\left(t_{j}-t_{j-1}\right)^{3}}{1+q_{j-1}} L+\sum_{j=1}^{m}\left(t_{j}-t_{j-1}\right)(j-1) M^{*}+L\right\} \\
& \approx 0.1317463686 .
\end{aligned}
$$

Therefore, according to Theorem 3.1, the initial value problem (4.1) has a unique solution on $J$. This means that our hypothesis is reasonable, that is, the uniqueness of the solution to the equation.

Example 4.2. Consider the following impulsive fractional $q_{k}$-difference equations

\Delta^{* *} x\left(t_{k}\right)=\frac{\left|x\left(t_{k}\right)\right|}{5(k+4)) \mid}, k=1,2, t_{k}=\frac{k}{5} \\
x(0)=0,{ }_{0} D_{\frac{7}{8}}^{\frac{3}{2}} x(0)=\frac{3}{4},{ }_{0} D_{\frac{7}{8}}^{\frac{1}{2}} x(0)=\frac{2}{3} .

Here, $\alpha_{k}=\frac{k^{2}-2 k+5}{2 k^{3}+k+2}, q_{k}=\frac{k^{3}-3 k+7}{2 k^{4}+k+8}, k=0,1,2, m=2, T=\frac{1}{2}, \beta=\frac{3}{4}, \gamma=$ $\frac{2}{3}, f(t, x(t))=\frac{x(t) \sin x^{2}(t)}{16\left(1+e^{t^{2}}\right)\left(e^{t}+|x(t)|\right)}, \varphi_{k}\left(x\left(t_{k}\right)\right)=\frac{\left|x\left(t_{k}\right)\right|}{4(k+2)}, \varphi_{k}^{*}\left(x\left(t_{k}\right)\right)=\frac{\left|x\left(t_{k}\right)\right|}{6(k+3)}, \varphi_{k}^{* *}\left(x\left(t_{k}\right)\right)$ $=\frac{\left|x\left(t_{k}\right)\right|}{5(k+4)}$.

Obviously, we have $|f(t, x(t))| \leq \frac{1}{64}(1+|x|), L=\frac{1}{64}, a=\frac{1}{12}, b=\frac{1}{18}, M^{\prime}=0.087$. Thus, all the assumptions in Theorem 3.3 are satisfied, which means that (4.2) has at least one solution.

In equation (4.2), if we set $f(t, x)=\frac{e^{-t}}{10}+\ln (1+|t|) x$, where $a(t)=\frac{e^{-t}}{10}, b(t)=$ $\ln (1+|t|)$, we can obtain $a=\frac{1}{10}, b=\ln 2$, and by calculation, we get $B_{1}=0.12<1$. That is to say, Theorem 3.2 is satisfied. However, if we set $f(t, x)=e^{-t}+\sin t|x|$, where $a(t)=e^{-t}, b(t)=\sin t$, by calculation, we get $a=b=1, B_{1}=1.167>1$. That is to say, $B_{1}<1$ is not necessary for the function $f(t, x)$ to be true.
